Subject: Work Session re: Parking & Sign Project Update

Madam Mayor and Members of City Council,

Background

The Sign Project was initiated to address the large volume of Traffic Control Orders (TCOs)—many dating back to the 1970s—and to modernize the City's parking and regulatory signage. Historically, signage and parking regulations were often enacted reactively. The project's intent is to shift to a consistent, standards-based approach for parking regulations across the City.

Project implementation began in 2023 and was paused in 2024. At the time of the pause, approximately 90% of the sign recommendations had been implemented, reflecting significant progress toward citywide consistency.

Since the pause, staff have reconvened internally to evaluate the progress, assess remaining items, and develop recommended enhancements to the original work. These proposed refinements have also been reviewed by our new engineering firm. Their assessment confirms that the project remains on the right track and that the enhanced recommendations are appropriate for this phase.

Summary

The initial phase of the project produced several key recommendations:

- Identify Signs for Replacement Bring existing signs into compliance with today's standards for clarity, visibility, and uniformity.
- 2. Compare Signs with Hundreds of Old TCOs Identify discrepancies between physical signs and legacy TCOs and resolve conflicts.
- 3. Recommendations for No-Parking Zones Adjacent to Schools Improve traffic safety and circulation around school sites.
- 4. Develop a Standard for No-Parking Locations Based on Fire Safety Needs Ensure consistent fire lane access and emergency response clearance.

The goal of today's work session is to:

Review the original recommendations and the work completed to date.

- Present the enhanced recommendations developed by staff and reviewed by the engineering firm.
- Discuss next steps for finalizing the standardized signage framework.
- Seek Council consensus on a path forward, including direction on completing implementation and addressing any outstanding TCO or signage conflicts

Conclusion

The Sign Project represents an important shift toward consistency, predictability, and standards in our regulatory signage. With Council's guidance, we aim to complete implementation and establish a reliable baseline for the community.
