- c. As of Monday July 12th, 372 residents responded they would like a tree relative to the 200 trees budgeted for the program
- d. Trees will be planted on a first requested, first served basis. Two hundred trees are planned to be planted in the fall of 2021 and the remainder will planted in the following year

3. DISCUSS FUTURE POTENTIAL PROJECTS

The Committee discussed possible future projects including:

- 1) Fundraising and deploying resources to residents in need of property upkeep
- 2) Beautification/Landscape Contest (Tour)

- a. Natalie informed the Committee that the City will be filling a newly created Facilities and Operations Director position

In addition, each park has a specific focus based on that park's current users.
