- Parks and Rec Director position will be permanently filled once the new city manager is hired. Dan will remain as interim Parks & Rec Director during this period.

### 3. Budget 24/25 – 25/26

- Meeting next week to go through budgets for 24/25 and 25/26.
- There is not much capitol, so much of the focus will be on programming.
- They will be replacing one of the Parks & Rec trucks.

Betty enjoys the senior programming very much, and the transportation is also great.

Melissa is happy to be part of the group and inquired when the Tot Lot shades (on the play structure) will be added back to for the season. Dan McMinn indicated it should happen in the next couple of weeks.

Andrew was really impressed with Dan McMinn's quick ability to get the lights on at the softball field last night. He also inquired as to whether there is a way to get another field for the girls to practice on?

Dad's Club currently has 6 fields they practice on, Mom's Club has 2 fields. There are also 6 travel teams. Dan McMinn welcomes bringing all parties together to discuss.

Ross Gavin said stakeholder meetings will help identify what is desired from the new city manager.
